The Fourth EAJS Doctoral Workshop
at Nissan Institute of Japanese Studies in Oxford, United Kingdom**

Objectives of the Fourth EAJS Workshop

The Fourth EAJS workshop aimed at supporting PhD students in allowing them to present their PhD projects to a number of experienced researchers during a two days workshop and getting their feedback.

Targeted were students who are working on a PhD project related to Japan. The overall aim of the workshop was to allow students interested in researching about Japan to participate from the knowledge of professors who have long experience researching and publishing about Japan. The main focus lay not on students who are enrolled in Japanese Studies. Other disciplines such as Political Science, Management and Social Studies were preferred. The workshop so tried to increase the quality of the presented PhD projects in other disciplines than Japanese Studies, because we assumed that students of Japanese Studies to have easier access to Japan experienced researchers and feedback.

Selection Procedures

The call for paper for the workshop was published at the EAJS homepage in January 2007 and send to the recipients of a number of Japan research related mailing lists. The deadline for application was the end of January 2007. Even though the application period was quite short, more than 30 PhD students applied. Interested students had to hand in a 10 page research proposal about the planned project. After this, the students were selected by Dr. Parissa Haghirian. The selection was based on following principles:

- 1) Quality of the PhD proposal (The proposal should contain a solid and understandable explanation of the planned PhD research project)
- 2) Medium stage of PhD project (Students were supposed to be have a very clear idea on what they would like to investigate, but at the same time should be in a stage in which feedback from experienced advisors could still shape and improve the planned PhD project)
- 3) PhD in the following topics: Management, Social Studies and Political Studies (these topics were preferred because the advisors were specialists in these fields)

After this, the selected participants were invited to prepare their participation. They were required to hand in another revised and improved proposal and to prepare a maximum 10 slides PowerPoint presentation for the workshop. They were further sent some guidelines to prepare these materials for the workshop and some instructions on how financial reimbursement would take place.
